**RESOLUTION REQUESTING HONORABLE CITY MAYOR OSCAR S. MORENO TO PROVIDE HAZARD DUTY BENEFITS TO BARANGAY NUTRITION SCHOLARS (BNS), BARANGAY HEALTH WORKERS (BHW) AND MEMBERS OF THE BARANGAY POLICE WHO ARE SERVING AS FRONTLINERS IN THEIR RESPECTIVE BARANGAYS FOR THE CONTAINMENT OF COVID-19 IN THE CITY**

**Whereas**, while the rest of the population are obliged to stay indoors, barangay health workers, nutrition scholars and barangay police risk their lives in order to protect the people of Cagayan de Oro city, despite meager allowances;

**Whereas**, to honor and acknowledge the sacrifices of all barangay frontliners performing beyond the call of duty amidst this pandemic, they also deserve to receive hazard duty benefits;

**Wherefore**, on motion by Councilor Ian Mark Q. Nacaya, duly seconded by Councilors Reuben R. Daba Edgar S. Cabanlas and Edna M. Dahino, be it

**Resolved**, to request Honorable City Mayor Oscar S. Moreno to provide hazard duty benefits to Barangay Nutrition Scholars (BNS), Barangay Health Workers (BHW) and members of the Barangay Police who are serving as frontliners in their respective barangays for the containment of COVID-19 in the City;
