

## Contract Agreement

THIS AGREEMENT, made this \_\_\_\_\_ day of JUN 29 2022, between the **City Government of Cagayan de Oro** (hereinafter called "the Entity") and **Vinnex Enterprises**, with office address at Jesus V. Serina St., Carmen, Cagayan de Oro City (hereinafter called the "Contractor").

  - K Credit line issued by a licensed bank, if any;
  - L Notice of Award of Contract and the Bidder's conforme thereto;
  - M Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may

become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
