WHEREAS the Entity invited Bids for certain goods, viz., **Supply and Delivery of Drugs and Medicines (Lot No. 2); PR No. 22-3927 dated November 14, 2022; SN 292 - 2022**, and has accepted a Bid by the Supplier for the supply of those goods in the sum of **Two Million Seven Hundred Twenty Five Thousand Five Hundred Forty Six and 00/100 Pesos Only (PhP2,725,546.00)**, (hereinafter called "the Contract Price").

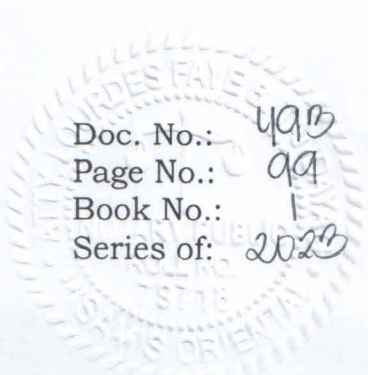

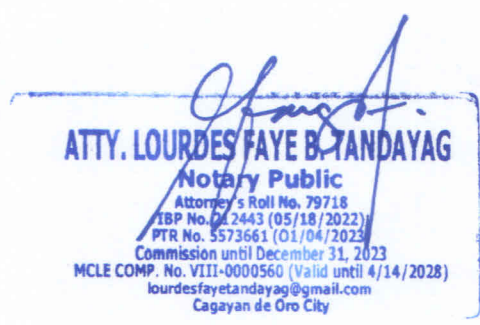

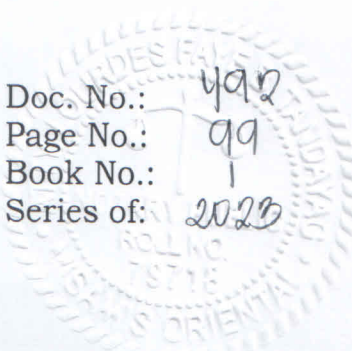
