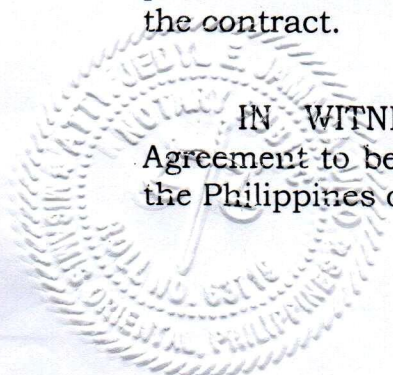
THIS AGREEMENT made this _____ day of 21 JUL 2023,

called "the Supplier") of the other part.

WHEREAS the Entity invited Bids for certain goods, viz., **Supply and Delivery of Drugs and Medicine (Lot No. 9); PR No. 23-0748 dated February 28, 2023; SN 81 - 2023**, and has accepted a Bid by the Supplier for the supply of those goods in the sum of **Two Million Two Hundred Nineteen Thousand Seven Hundred Forty and 00/100 Pesos (PhP2,219,740.00)**, (hereinafter called "the Contract Price").

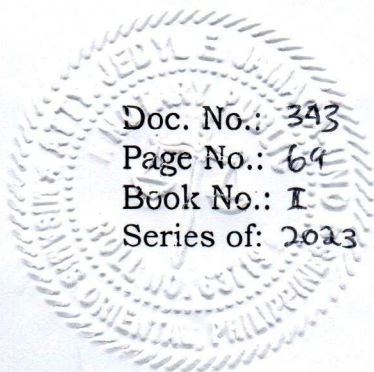

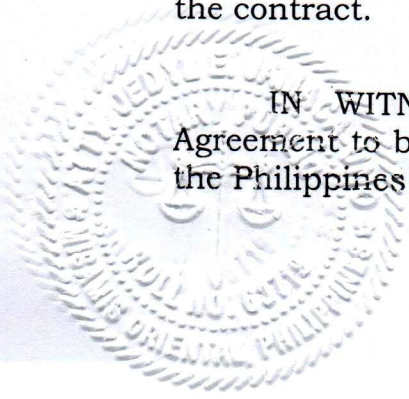

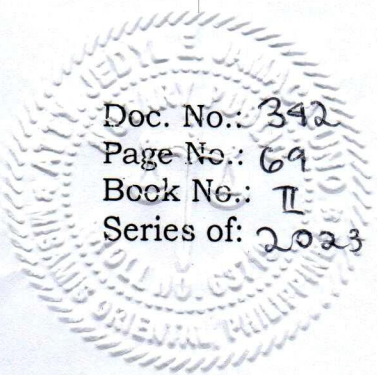
