WHEREAS the Entity invited Bids for certain goods, viz., Supply and Delivery of 26 Units Projector and other items; PR No. 23-2849 dated August 10, 2023; SN 356 - 2023, and has accepted a Bid by the Supplier for the supply of those goods in the sum of Two Million Sixty Thousand Five Hundred and 00/100 Pesos (PhP2,060,500.00), (hereinafter called "the Contract Price").

 - G the Entity's Notification of Award.
- In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract
- The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
