THIS AGREEMENT made this _____ day of _____, ^{DEC 05 2024}
between the **City Government of Cagayan de Oro** of the Philippines
(hereinafter called "the Entity") of the one part and **Circle M
Merchandise Trading Corporation** of B-3 L-21 Stanford St., Cambridge
Subd., Iponan, Cagayan de Oro City, (hereinafter called "the Supplier") of
the other part.

WHEREAS the Entity invited Bids for certain goods, viz., **Supply
and Delivery of Rice 50 Kg and other items; PR No. 24-2833 dated
July 25, 2024; SN 271 - 2024**, and has accepted a Bid by the Supplier
for the supply of those goods in the sum of **Seven Million Eight
Hundred Seventy Four Thousand Six Hundred Twenty Three and
25/100 Pesos (PhP7,874,623.25)**, (hereinafter called "the Contract
Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents, as annexed, shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - A the Bid Form and the Price Schedule submitted by the Bidder;
 - B the Schedule of Requirements;
 - C the General Conditions of Contract;
 - D the Special Conditions of Contract;
 - E the Performance Security; and
 - F the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
