



### JOINT OFFICIAL STATEMENT City of Cagayan de Oro – DTI Misamis Oriental

Pursuant to the National IATF Resolution No. 42 which approved the joint recommendation of the Department of Trade and Industry (DTI) and the Department of Tourism (DOT) on <u>dine-in operation</u> of restaurants and fast food establishments that

"The resumption of, and continued operations of restaurant dine-in services shall be subject to the proprietors' compliance with the proper health protocols set by the DTI x x x. A post-audit mechanism led by the DTI x x x shall be established to determine noncompliance to the prescribed minimum health protocol which shall be a ground for temporary closure to allow the outlet to correct the deficiencies".

restaurants, fast food establishments, and other processed food retail outlets (e.g., karenderias, eateries) that have already complied with the DTI guidelines may start their respective dine-in operations, subject to post-audit by monitoring teams from the City Government, the DTI, or a combination of any of these offices.

Covered business establishments may secure their copies of the guidelines from the official website of the Department of Trade and Industry (www.dti.gov.ph), or from the DTI Philippines official Facebook page.

In the absence of Internet access, printed copies may be secured from the Department of Trade and Industry – Misamis Oriental Provincial Office, Tiano corner Hayes Sts., Cagayan de Oro City.

#### RESOLUTION NO. 42

Series of 2020 June 1, 2020

WHEREAS, on March 16, 2020, to prevent the sharp rise of COVID-19 cases in the country, the President placed the entirety of Luzon under Enhanced Community Quarantine until April 14, 2020;

WHEREAS, on March 30, 2020, to develop a science-based approach in determining whether the Enhanced Community Quarantine in Luzon should be totally or partially lifted, extended, or expanded to other areas, the Inter-Agency Task Force (IATF) convened a sub-Technical Working Group tasked to define parameters in assessing recent developments in the Philippine COVID-19 situation;

WHEREAS, on April 3, 2020, the IATF finalized the parameters for deciding on the lifting or extension of the Enhanced Community Quarantine in Luzon, which include trends on the COVID-19 epidemiological curve, the health capacity of the country, social factors, economic factors, and security factors;

WHEREAS, on April 30, 2020, the Office of the Executive Secretary issued Executive Order (E.O.) No. 112 Imposing an Enhanced Community Quarantine in High-Risk Geographic Areas of the Philippines and a General Community Quarantine in the Rest of The Country from 01 To 15 May 2020, Adopting The Omnibus Guidelines On The Implementation Thereof, And For Other Purposes;

WHEREAS, on May 23, 2020, pursuant to the authority granted to the IATF under E.O. 112, the IATF issued and published amended Omnibus Guidelines on the Implementation of the Community Quarantine in the Philippines;

WHEREAS, as of June 01, 2020, there is a total of eighteen thousand six hundred thirty-eight (18,638) confirmed cases in the Philippines;

NOW, THEREFORE, BE IT RESOLVED, as it is hereby resolved, that the IATF approves the following:

A. The IATF adopts SafePass for COVID-19 Prevention and Incident Management platform for all business establishments which aims to complement the previously adopted StaySafe.ph.

Like all other applications adopted in the ICT Ecosystem, SafePass will be subjected to continued compliance with relevant cybersecurity, data privacy, and confidentiality laws, as well as similar guidelines and protocols as may be issued by the IATF through the Sub-Technical Working Group (TWG) on Information and Communications Technology. As such, SafePass will be made to disclose application permissions to its users;

- B. The joint recommendations of the Department of Trade and Industry (DTI) and Department of Tourism (DOT) on restaurant dine-in operations are hereby approved, the specifics of which are as follows:
  - The minimum public health standards protocol is cleared for distribution to and compliance of the concerned sector; and
  - 2. The resumption of, and continued operations of restaurant dine-in services shall be subject to the proprietors' compliance with the proper health protocols set by the DTI and DOT. A post-audit mechanism led by the DTI and DOT shall be established to determine noncompliance to the prescribed minimum health protocol which shall be a ground for temporary closure to allow the outlet to correct the deficiencies.
