RESOLUTION NO. 13592-2020

RESOLUTION EARNESTLY REQUESTING HONORABLE CITY MAYOR OSCAR S. MORENO AND/OR PUNONG BARANGAYS OF CAGAYAN DE ORO CITY TO RESCHEDULE OR POSTPONE THE SERVING OR IMPOSITION OF THE ADMINISTRATIVE PENALTY OF COMMUNITY SERVICE TO PERSONS APPREHENDED FOR VIOLATION OF VARIOUS ORDINANCES IN RELATION TO THE COVID-19 PANDEMIC, AFTER THE LIFTING OF THE COMMUNITY QUARANTINE IN THE CITY TO AVOID THE CLUSTERING OF PEOPLE

Whereas, it has been observed that those apprehended for various offenses in relation to COVID-19 rules, regulations and ordinances are unavoidably clustering in areas to serve the administrative penalty of community service, which may expose them to the transmission of the COVID-19 virus;

Wherefore, on motion by Councilor Ian Mark Q. Nacaya, duly seconded by Councilors Jay R. Pascual, Maria Lourdes S. Gaane and Reuben R. Daba, be it

Resolved, to request Honorable City Mayor Oscar S. Moreno and/or Punong Barangays of Cagayan de Oro City to reschedule or postpone the serving or imposition of the administrative penalty of community service to persons apprehended for violation of various ordinances in relation to the COVID-19 pandemic, after the lifting of the community quarantine in the City to avoid the aggregation of people;

Resolved further, to forward copies of this Resolution to Honorable City Mayor Oscar S. Moreno and to the different Punong Barangays of Cagayan de Oro City for their information.
