RESOLUTION NO. 13598-2020

RESOLUTION REQUESTING THE CITY SOCIAL WELFARE DEPARTMENT TO INTERCEDE WITH THE DEPARTMENT OF SOCIAL WELFARE DEPARTMENT (DSWD) FOR THE EXTENSION OF THE DEADLINE IN THE SUBMISSION OF NAMES WHO ARE NOT LISTED IN THE 2015 CENSUS BUT ARE QUALIFIED TO RECEIVE THE SOCIAL AMELIORATION PROGRAM (SAP)

Whereas, the Social Amelioration Program is a cash emergency subsidy program for 18 million Filipino families whose lives are greatly affected by the global pandemic COVID-19;

Whereas, the beneficiaries thereof are identified based on the 2015 Census, and there are still thousands of qualified beneficiaries who are not in the list;

Wherefore, on motion by Councilor Ian Mark Q. Nacaya, duly seconded by Councilors Reuben R. Daba and John Michael L. Seno, be it

Resolved, to request the City Social Welfare Department to intercede with the Department of Social Welfare Department (DSWD) for the extension of the deadline in the submission of names who are not listed in the 2015 Census but are qualified to receive the Social Amelioration Program (SAP);

Resolved further, to forward a copy of the Resolution to **Mr. Michael Christopher Fabello**, Officer-in-Charge, City Social Welfare and Development Office, this City, for his information.
