RESOLUTION NO. 13600-2020

RESOLUTION EARNESTLY REQUESTING THE NATIONAL INTER-AGENCY TASK FORCE ON EMERGING INFECTIOUS DISEASES (IAFT-EID) TO FAST TRACK THE DELIVERY OF COVID-19 TEST KITS TO CAGAYAN DE ORO CITY

Whereas, among the recommendations of the World Health Organization (WHO) to combat the spread of COVID-19 aside from community quarantine, social distancing and wearing of face masks, is the mass testing of high-risk and vulnerable patients especially that there are infected people who asymptomatic of the said disease;

Whereas, per information gathered by this Body, there is limited COVID-19 testing kits at the Northern Mindanao Medical Center (NMMC), this City, and the said COVID-19 center is still waiting for the delivery of supply thereof from DOH-Manila;

Whereas, it is paramount that such testing kits be delivered immediately especially that Cagayan de Oro City has recently recorded five (5) COVID-19 positive patients;

Wherefore, on motion by Councilor Ian Mark Q. Nacaya, duly seconded by Councilors Reuben R. Daba, Jay R. Pascual and John Michael L. Seno, be it

Resolved, to request the National Inter-Agency Task Force on Emerging Infectious Diseases (IAFT-EID) to fast track the delivery of COVID-19 test kits to Cagayan de Oro City;

Resolved further, to forward a copy of the Resolution to Secretary Francisco Duque, Chairman, National Inter-Agency Task Force on Emerging Infectious Diseases (IAFT-EID), Metro Manila, Philippines, for his information.
